6. Distance Learning

CTF Staff

- Explanation of the distance learning program
  - Dedicated \$25 million to the initiative
  - Enough service connections for 400,000 students
  - CDE identified districts that would be eligible to apply for the program
  - Districts would apply directly with CTF
  - We have provisions for mobile broadband long before Covid
  - We are looking for advice and guidance from the AC regarding future prospects and direction of mobile broadband

AC member Belleau

- Appreciate partnership with CTF and broadband support from April through September
- Results of survey sent to schools
  - Request for 760,000 devices
  - <sup>1</sup>/<sub>2</sub> million hotspots
- T-Mobile offered 100k hotspots, Verizon offered 250k hotspots at low costs
- CASF put up \$5 million for purchases of devices
- Schools want to and need to give connections to students

(Q): Why not fund devices from larger districts, since the problem falls more along income lines?

(A):

- Small and medium rural districts chosen because it fell in line with Governor's initiative and objective of digital divide
- Not enough funds for everyone
- Large districts have more access to funds
- Large districts often have existing programs

(Q): What about residential schools for the Deaf?

(A): Students of the state special schools are at home and are all connected

(Q): What is the carrier allocation of the hotspots?

(A):

- All four of the big carriers are being used
- There is interest in other opportunities
- Some districts are interested in microwave links, satellite connectivity, StarLink

## (Q) How is it billed?

(A):

- School district is responsible for paying
- Carrier would offer a discount and come to CTF for reimbursement of the discount
- CTF paying a projected \$14 million so far

(Q): What is the sustainability of this initiative?

(A): Have not discussed longer term.

## 7. Nominate representatives for vacancies

Nomination for Kim Klupenger for Rural Clinics/Telemedicine seat failed due to residing in Oregon.

Nomination for Anwar Abbas for Rural Clinics/Telemedicine deferred to next AC meeting

Committee confirmed nomination of Kate Beck for Public Advocates Office primary seat.

AC member Calvin Chang is retiring from UC Davis Health. If representing in the interest of healthcare and not related to his employer, he can stay as a member until the end of his term.

- Cash balance \$94.7 million
- Local assistance decreased by \$20 million over last three years
- Is the fund a target for raiding by the legislature to fill budget deficit?
  - All the CTF funds have been earmarked
  - There was an initial inquiry, but the legislature has looked elsewhere, like Lifeline
