Re: SureWest TeleVideo DIVCA Franchise – Notice of Merger Into Consolidated Communications Enterprise Services, Inc. and Associated Name Change

Dear Michael:

Pursuant to the California Public Utilities Commission's ("Commission") General Order ("G.O.") 169, Section VII(F), I am providing notice that SureWest TeleVideo has been merged into Consolidated Communications Enterprise Services, Inc. ("CCES"). The Commission approved the corporate reorganization by which the merger occurred in Decision ("D.") 16-04-008, and I am writing to provide appropriate notice regarding the merger in the video franchising context, and to ensure that the Commission's records are clear regarding the corporate entity of the holder of Video Franchise No. 29. Franchise No. 29 was issued to SureWest TeleVideo on January 1, 2009, and SureWest TeleVideo was merged into CCES on April 19, 2016. From that time forward, CCES has continued to submit annual reports, pay user fees, and comply with the other requirements of the state video franchise. This letter confirms the merger and the updated name of the franchise holder.


