VIOLATIONS

You are hereby cited for having violated section(s) of the Public Utilities (Pub. Util.) Code Commission General Order (G.O.) 157-E as described below. These violations occurred during August 1, 2022 through October 12, 2023.

- (1) Advertised as a charter party carrier without the proper permit or certificate, in violation of Pub. Util. Code Section 5414.5. [12 counts]
- (2) Illegal display of a TCP number on a vehicle, in violation of Pub. Util. Code Section 5381 and 5411.3 and General Order (G.O.) 157-E, Part 4.08. [1 count]

STATEMENT OF FACTS

The above violations are documented in the attached Investigation Report, which consists of carrier's records and substantiating documents obtained from other sources.

RESPONSE

TEB used the Penalty Assessment Methodology adopted in Resolution M-4846 and considered mitigating and exacerbating factors in setting the fine.

You are hereby called upon to answer this citation on or before November 10, 2023. By way of such answer, you may either:

- (1) Pay a fine of **\$6,000** pursuant to Pub. Util. Code section 5378. (Submit a cashier's check or money order payable to California Public Utilities Commission using the provided *Citation Compliance Agreement*. Upon payment, the fine will be deposited in the State Treasury to the credit of the General Fund and the Commission staff will deem the matter closed.) **or**
- (2) Contact the Supervisor below to make payment arrangements, **or**
- (3) Contest this citation by filing an appeal. See the provided documents entitled
 - *How to File an Appeal* and
 - *Instructions for Filing a Notice of Appeal and Certificate of Service for a Citation Appeal*.

If you fail to respond by November 10, 2023, you will be in default and will have forfeited your right to appeal the Citation. In addition, your operating authority will be immediately suspended and may be subsequently revoked, pursuant to Resolution ALJ-187. The Commission may also act through a civil or criminal proceeding to recover any unpaid fine and ensure compliance with applicable statutes and Commission orders.

INTRODUCTION

On August 3, 2022, I was assigned to investigate Taco Tour LLC (hereafter TT LLC) following a settlement agreement where the owner, Luke Wuellner, had agreed to pay a fine and obtain operating authority after being cited under Citation T-21-12-003. The owner continued to advertise passenger transportation for hire service without paying the Citation fine and obtaining the authority to operate.

PRIOR ENFORCEMENT HISTORY

The Transportation Enforcement Branch's (TEB) records show that TT LLC has been cited previously On December 24, 2021, the company was issued Citation No. T-21-12-003 for operating with a revoked authority; operating without a Public Liability and Property Damage (PL&PD) insurance coverage in force and on file with the California Public Utilities Commission (Commission); failing to obtain the minimum PL&PD insurance level for a 16 passenger vehicle; and advertising as a charter party carrier of passengers without a valid authority [**Attachment 1**]. Though a settlement agreement, the Citation's \$12,000 fine was reduced to \$11,000 [**Attachment 2**]. In the settlement agreement, TT LLC agreed to pay the fine and obtain an authority to operate by April 6, 2022 [**Attachment 2**]. The company failed to comply with the settlement agreement. [**Attachment 3**].

VIOLATIONS

The investigation for the period of August 1, 2022, through October 12, 2023, disclosed violations of the following provisions of the Public Utilities Code (Pub. Util. Code) and Commission's General Order (G.O.):

- **Advertised as a charter party carrier without the proper permit or certificate in violation of Pub. Util. Code Section 5414.5. [12 Counts]**

Pub. Util. Code Section 5414.5 states: "Every corporation or person who knowingly and willfully issues, publishes, or affixes, or causes or permits the issuance, publishing, or affixing,

of any oral or written advertisement, broadcast, or other holding out to the public, or any portion thereof, that the corporation or person is in operation as a charter-party carrier of passengers without having a valid certificate or permit issued under this chapter is guilty of a misdemeanor punishable if an individual, by a fine of not more than one thousand dollars (\$1,000) or by imprisonment in the county jail for not more than six months, or by both, or if a corporation, by a fine of not more than five thousand dollars (\$5,000).”

Business and Professions (B&P) Code Sections 17200 and 17500 states in part that unfair competition shall mean and include an unfair or fraudulent business act or practice and unfair, deceptive, untrue, or misleading advertising and any act prohibited by Chapter 1 of the B&P Code. **Attachment 4** contains copies of Transportation Licensing and Analysis Branch’s (TLAB) order of suspension, June 5, 2020, and order of revocation, June 5, 2020.

Cease and desist notices were sent to TT LLC on August 4, 2022, and July 3, 2023 [**Attachment 5**]. However, the carrier continued to advertise passenger tour services on their website, www.tacotoursd.com. [**Attachment 6**].

- **Illegal display of a Charter Party Transportation Carrier Permit (TCP) number on a vehicle in violation of the Pub. Util. Code Sections 5381 and 5411.3 and G.O. 157-E Part 4.08. [1 Count]**

Pub. Util. Code Section 5411.3 states in part that every charter-party carrier of passengers, who displays on any vehicle any identifying symbol other than the one prescribed by the Commission or who fails to remove an identifying symbol when required by the Commission, is guilty of a misdemeanor and is punishable by a fine of not more than two thousand five hundred dollars (\$2,500), by imprisonment in the county jail for not more than one year, or by both.

I observed TT LLC displaying a revoked TCP number on their bus, license plate number [REDACTED], during a field observation conducted on August 28, 2023 [**Attachment 7**].

NARRATIVE

On June 24, 2021, Transportation Enforcement Branch (TEB) staff was assigned to investigate the operations and practices of Taco Tours LLC (Taco Tours) as the result of a permitted carrier complaint alleging that Taco Tours was operating and advertising without a valid permit.

VIOLATIONS

The investigation for the period of December 2, 2020 through August 19, 2021 disclosed violations of the following provisions of the Public Utilities Code (Pub. Util. Code) and Commission General Order (G.O.):

- 1. Operated as a charter-party carrier after revocation of its operating authority in violation of Pub. Util. Code Section 5379 [129 counts].**

Transportation Licensing and Analysis Branch (TLAB) records show that Taco Tours charter-party certificate was suspended on June 5, 2020 for failure to maintain adequate public liability and property damage insurance (PL&PD) and was subsequently revoked on December 2, 2020. Attachment 1 contains copies of TLAB notices.

A review of Taco Tour's daily log that was provided by Mr. Luke Wuellner on September 21, 2021, disclosed that Taco Tour conducted at least 129 days (169 charter trips) of operations from December 2, 2021 through August 19, 2021 as a charter-party carrier after its authority was revoked as shown in **Table 1** and **Attachment 2**.

2. **Conducted operations as a charter-party carrier of passengers without evidence of Public Liability and Property Damage (PL&PD) insurance coverage in effect and on file with the Commission in violation of Pub. Util. Code Sections 5387(a)(c)(1)(A), 5391, and G.O. 115-G [95 counts].**

Pub. Util. Code Section 5387 states in part that it is unlawful for the owner of a charter-party carrier of passengers to permit the operation of a vehicle upon a public highway for compensation without having complied with the accident liability protection requirements of Section 5391.

Pub. Util. Code Section 5391 states in part that the Commission shall require the charter-party carrier of passengers to procure, and to continue in effect during the life of the permit or certificate, adequate protection against liability

imposed by law upon the charter-party carrier of passengers for the payment of damages for personal bodily injuries, including death and protection against damage or destruction of property.

On September 21, 2021, the Taco Tour daily log provided by Mr. Luke Wuellner disclosed that Taco Tours operated a passenger carrier vehicle without obtaining evidence of the required public liability coverage from 12/04/2020 to at least 06/19/2021 as shown in **Table 1** and **Attachment 2**.

- 3. Failed to obtain the required minimum level of public liability insurance coverage for one vehicle in violation of Pub. Util. Code Section 5391 and G.O. 115-G for 16 passengers or more [1 count].**

G.O. 115-G requires charter party carriers to provide and continue in effect liability protection in the amount of not less than \$5 million for vehicles with a seating capacity of 16 passengers or more including the driver.

On September 21, 2021, Mr. Wuellner submitted to TEB staff an Acord Certificate of Liability Insurance document showing Taco Tours insurance coverage for \$1 Million, effective 06/20/2021 through 06/20/2022, under policy number [REDACTED] **[Attachment 3]**.

Taco Tours operated a 22-seat capacity vehicle without obtaining evidence of the required public liability coverage of \$5 million as shown in **Table 2** and **Attachment 2**.

4. Advertised as a charter-party carrier without having a valid authority in violation of Pub. Util. Code Section 5414.5 [4 counts].

Pub. Util. Code Section 5414.5 states: "Every corporation or person who knowingly and willfully issues, publishes, or affixes, or causes or permits the issuance, publishing, or affixing, of any oral or written advertisement, broadcast, or other holding out to the public, or any portion thereof, that the corporation or person is in operation as a charter-party carrier of passengers without having a valid certificate or permit issued under this chapter is guilty of a misdemeanor punishable if an individual, by a fine of not more than one thousand dollars (\$1,000) or by imprisonment in the county jail for not more than six months, or by both, or if a corporation, by a fine of not more than five thousand dollars (\$5,000)."

Business and Professions (B&P) Code Sections 17200 and 17500 states in part unfair competition shall mean and include an unfair or fraudulent business act or practice and unfair, deceptive, untrue, or misleading advertising and any act prohibited by Chapter 1 of the B&P code.

On June 5, 2020, Taco Tour's operating authority was suspended by TLAB for failure to maintain adequate public liability and property damage insurance coverage and was subsequently revoked on December 2, 2020 for the same reason. **Attachment 1** contains copies of the TLAB notices.

On August 12, 2021, TEB staff sent a Cease and Desist letter to Luke Wuellner of Taco Tours LLC via email [**Attachment 4**]. The Cease and Desist letter directed Taco Tours to stop illegal advertising until it has obtained a valid permit.

On August 5 and December 10, 2021, the carrier was observed advertising illegally without a valid authority on the Taco Tour website (www.tacotoursd.com) [**Attachment 5a**]. On December 10, 2021, the carrier was observed also advertising illegally without a valid authority on Facebook.com, Yelp.com, Groupon.com [**Attachments 5b, 5c, and 5d respectively**]. These advertisements all list the phone number (858) 220-3573.

TacoTourSD.com: This website, on December 10, opened with a pop-up discount offer showing Santa Clause with a sleigh being pulled by tacos instead of reindeer offering a "Buy one, get one 50% off!". Once the pop-up was cleared, the regular company website showed. The regular Taco Tour San Diego company webpage lists the correct phone number and the correct email address for Luke. The webpage lists a description of the tours and shows pictures of tacos, the bus, customers in group photo, and other coastal scenery. Under "Message From Luke (owner/operator)": there is a personal message from Luke to potential customers with his photo eating a taco. There are two packages offered for sale: Taco Tour Lunch Tour for \$30, and Taco Tour Sunset Tour also for \$30. Each product has a link to, "Purchase Lunch Tour" or "Purchase Sunset Tour" which both lead to the link: <https://www.tacotoursd.com/book-online>, where you can purchase tickets after selecting a desired date and time. Not shown on the website, as required by P.U. Code, is the company TCP number [**Attachment 5a**].

Facebook: Webpage shows on Taco Tour San Diego Facebook homepage, shows pictures of tacos, tours, and scenery along with Services listed as "Taco Tour San Diego, lunch like a local on a guided historical tour thro... \$26.50" It also lists the

correct website for the company, phone number, and way to contact the manager [Attachment 5b].


Yelp: Webpage shows on Yelp.com that Taco Tour San Diego is open from 9am to 6pm on the date of the observation and that the listing is "claimed" by the company. The correct website for the Taco Tour website is listed along with the correct phone number, address of the company, and recent reviews. Under "COVID-19 updates" the site says, "Taco Tour San Diego is OPEN for business", which according to the website posted on July 22, 2020. Under "About the Business" the site lists Luke. W. as Business Owner and also says, "Tour San Diego Like a Local! Enjoy the best tacos and local attractions that San Diego has to offer. Tours run twice daily during Lunch and Sunset. Same day availability. 10% off for first time patrons." [Attachment 5c].

Groupon: Webpage shows that Taco Tour - Up to 10% Off - San Diego, CA provides Food Tours. Since this is a coupon site, it has discounted rates available for purchase for one, two, or four persons. The webpage boasts that the page has gotten 20 views already the day of the observation. The correct phone number, and link to correct company website are listed along with recent customer reviews. The address listed is that of where the tours start (500 Pacific Highway, San Diego, CA 92101) and not that of the company office like other websites. Under, "About This Deal" are details about the tour being historical and about 3.5 to 4 hours long, a link to tour schedules, departure location, a statement that food and drink are not included, and that there are three of four stops on each tour [Attachment 5d].

IMPORTANT NOTICE REGARDING OPERATIONS WITHOUT
AN ACTIVE PERMIT OR CERTIFICATE

The Public Utilities Code was amended effective January 1, 2010, to provide serious sanctions for, among other things, conducting operations during a period of liability insurance suspension or conducting operations without a permit or certificate from the Commission. Section 5387(c)(1) was added to the Code as follows:

- (c)(1) A charter-party carrier shall have its authority to operate as a charter-party carrier permanently revoked by the Commission or be permanently barred from receiving a permit or certificate from the Commission if it commits any of the following acts:
- (A) Operates one or more buses or vehicles without having been issued a permit or certificate from the Commission.
 - (B) Operates one or more buses with a permit that was suspended by the Commission pursuant to Section 5378.5.
 - (C) Commits three or more liability insurance violations within a two-year period for which it has been cited.
 - (D) Operates one or more buses or vehicles with a permit that was suspended by the Commission during a period that the charter-party carrier's liability insurance lapsed for which it has been cited.
 - (E) Knowingly employs a driver who does not have a current and valid driver's license of the proper class, a passenger vehicle endorsement, or the required certificate to drive bus(es) or vehicle(s).
 - (F) Has one or more buses or vehicles improperly registered with the Department of Motor Vehicles.

(E) Knowingly employs a driver who does not have a current and valid driver's license of the proper class, a passenger vehicle endorsement, or the required certificate to drive bus(es) or vehicle(s).

(F) Has one or more buses or vehicles improperly registered with the Department of Motor Vehicles.

NOTICE TO CEASE AND DESIST

Subject: Operations and advertising after revocation of a charter-party "A" permit

On December 02, 2020 your charter-party operating authority was revoked for failure to maintain adequate public liability and property damage insurance coverage.

SETTLEMENT AGREEMENT BETWEEN TACO TOUR, LLC AND THE CONSUMER PROTECTION AND ENFORCEMENT DIVISION OF THE CALIFORNIA PUBLIC UTILITIES COMMISSION RESOLVING CITATION APPEAL K.22-01-004 AS TO CPED CITATION T.22-01-003 ISSUED ON DECEMBER 24, 2021

Taco Tour, LLC, (“Taco Tour”), a Charter Party Carrier of Passengers (TCP# 38185-A) based in San Diego, CA, and the Consumer Protection and Enforcement Division (“CPED”) of the California Public Utilities Commission (“CPUC” or “Commission”) are hereinafter collectively referred to as the “Settling Parties”. On the following terms and conditions, the Settling Parties hereby agree to settle, and fully resolve Citation Appeal K.22-01-004 and its subject CPED Citation T.22-01-003.

This Settlement Agreement shall become effective upon review and approval by the Commission in a written resolution upon filing of a Joint Motion for Approval of the Settlement by the Settling Parties within 15 days after the full execution of this Settlement Agreement.

This Settlement Agreement is entered into as a compromise of disputed claims and defenses in order to minimize the time, expense, and uncertainty of continued litigation. The Settling Parties agree to the following terms and conditions as a complete and final resolution of the Citation Appeal (K.22-01-004) filed by Taco Tour on January 13, 2022. This Settlement Agreement constitutes the sole agreement between the Settling Parties concerning the subject matter of this proceeding.

I. AGREEMENT

- A. Taco Tour admits to the violations contained in Citation T.22-01-003 as follows:
- Operated as a charter-party carrier after revocation of its operating authority in violation of Public Utilities Code (“Pub. Util. Code”) Section 5379 [129 counts];
 - Conducted operations as a charter-party carrier of passengers without evidence of Public Liability and Property Damage (PL&D) insurance coverage in effect and on file with the Commission in violation of Pub. Util. Code Sections 5387(a)(c)(1)(A), 5391, and General Order (“GO”) 115-G [95 counts];
 - Failed to obtain the required minimum level of public liability insurance coverage for one vehicle in violation of Pub. Util. Code Section 5391 and GO 115-G for 16 passengers or more [1 count]; and
 - Advertised as a charter-party carrier without having a valid authority in violation of Pub. Util. Code Section 5414.5 [4 counts].
- B. Taco Tour shall pay a reduced fine of \$11,000.00 (Eleven Thousand Dollars) of the original \$12,000.00 (Twelve Thousand Dollars) fine imposed by Citation T.22-01-003. Payments shall be made in 12 (twelve) monthly installments consisting of 11 (eleven) installments of \$916.66 (Nine hundred sixteen dollars and sixty-six cents) and a twelfth (12th) installment of \$916.74 (Nine hundred sixteen dollars and seventy-four cents) beginning within 30 days from the date this Settlement Agreement is approved by the Commission.

Payment shall be check or money order and shall be made payable to the California Public Utilities Commission. Taco Tour shall write on the face of the check or money order: "For deposit to the State of California General Fund for Citation Appeal K.22-01-004". Payment shall be delivered to:

- C. Taco Tour's operating permit/license, TCP# 38185-A, remains revoked. Taco Tour must submit to the Commission a new fully completed application for an applicable permit to operate as a charter party carrier.
- D. The Commission shall process Taco Tour's application within 90 days upon receipt of the fully completed application.
- E. Taco Tour shall not transport passengers until after they have received an applicable charter party carrier permit.

II. OTHER MATTERS

A. The Settling Parties agree to seek expeditious approval of this Settlement Agreement and the terms of the settlement, and to use their reasonable best efforts to secure Commission approval of it without change, including by filing a joint motion seeking approval of this Settlement Agreement and any other written filings, appearances, and other means as may be necessary to secure Commission approval. The Settling Parties agree to actively and mutually defend this Settlement Agreement if its adoption is opposed by any other party in proceedings before the Commission. In accordance with Rule 12.6 of the Commission's Rules of Practice and Procedure, if this Settlement Agreement is not adopted by the Commission, its terms are inadmissible in any evidentiary hearing unless their admission is agreed to by the Settling Parties. In the event the Commission rejects or modifies the Settlement Agreement, Settling Parties reserve all rights set forth in Rule 12.4 of the Rules of Practice and Procedure. The provisions of this paragraph shall impose obligations on the Settling Parties immediately upon the execution of this Settlement Agreement.

B. The Settling Parties have bargained in good faith to reach the agreement set forth herein. The Settling Parties intend the Settlement Agreement to be interpreted as a unified, interrelated agreement. The Settling Parties agree that no provision of this Settlement Agreement shall be construed against any of them because a particular party or its counsel drafted the provision.

C. The rights conferred and obligations imposed on any of the Settling Parties by this Settlement Agreement shall inure to the benefit of or be binding on that Settling Party's successors in interest or assignees as if such successor or assignee was itself a party to this Settlement Agreement.

D. Should any dispute arise between the Settling Parties regarding the manner in which this Settlement Agreement or any term shall be implemented, the Settling Parties agree, prior to initiation of any other remedy, to work in good faith to resolve such differences in a manner consistent with both the express language and the intent of the Settling Parties in entering into this Settlement Agreement.

E. This Settlement Agreement is not intended by the Settling Parties to be precedent for any other proceeding, whether pending or instituted in the future. The Settling Parties have assented to the terms of this Settlement Agreement only for the purpose of arriving at the settlement embodied in this Settlement Agreement. Each Settling Party expressly reserves its right to advocate, in other current and future proceedings, or in the event that the Settlement Agreement is rejected by the Commission, positions, principles, assumptions, arguments and methodologies which may be different than those underlying this Settlement Agreement, and the Settling Parties expressly declare that, as provided in Rule 12.5 of the Commission's Rules of Practice and Procedure, this Settlement Agreement should not be considered as a precedent for or against them.

F. This Settlement Agreement may be executed in counterparts.

G. The Settling Parties hereby agree that this Settlement Agreement is entered into as a compromise of disputed claims and defenses in order to minimize the time, expense, and uncertainty of continued litigation in this proceeding.

H. Nothing in this Settlement Agreement relieves Taco Tour from any responsibilities imposed on it by law or Commission rules, orders, or decisions.

I. In reaching this Settlement Agreement, the Settling Parties expect and intend that neither the fact of this settlement nor any of its specific contents will be admissible as evidence of fault or liability in any other proceeding before the Commission, any other administrative body, or any court. In this regard, the Settling Parties are relying on Evidence Code Section 1152(a) and Public Utilities Code Section 315. Furthermore, such use of this Settlement Agreement or any of its contents in any other proceeding before the Commission, any other administrative body, or any court would frustrate and interfere with the Commission's stated policy preference for settlements rather than litigated outcomes. See Pub. Util. Code § 1759(a).

J. This Settlement Agreement represents the sole and entire agreement between the Settling Parties with respect to the subject matter hereto and supersedes all prior agreements, negotiations, and discussions between the Settling Parties hereto and/or their respective counsel with respect to the subject matters covered hereby.

K. Each Settling Party whose signature is affixed hereto in a representative capacity represents and warrants that they are authorized to execute this Settlement Agreement on behalf of and to bind the entity on whose behalf his or her signature is affixed, and each of the Settling Parties represents and warrants that the person executing this Settlement Agreement on its behalf has full and complete legal authority to do so.

L. This Settlement Agreement contains the entire agreement between the Settling Parties. The terms of the Settlement Agreement are contractual and not merely recital. This Settlement Agreement is executed without reliance upon any representations not contained in this document. The undersigned Settling Parties have carefully read, understood, and had the opportunity to seek advice of counsel concerning the content of this Settlement Agreement and sign the agreement of their own free will.


